## **1. First Day Activities**

### **1.1 Introduction and Opening Remarks**

Representatives of member organisations began the Annual General Meeting by registering their names before the Chairperson of Policy Forum, Moses Kulaba, made his opening remarks. Thereafter, the Chairperson welcomed all members from Dar es Salaam and upcountry, and invited each participant to introduce her/him-self by name and the organisation s/he represents.

The new member organisations announced by the Chairperson were **CADA**, **ANSAF** and **DARAJA**. The total number of organisations was declared to have grown up to 104. On the other hand, the Chairperson announced the dismissal of Shinyanga Foundation Fund following its representative presenting a fake air ticket for fraudulent reimbursement.

The representative of KIVULINI Women's Rights Organisation from Mwanza, Ms Maimuna Kanyamala was given a special recognition and applause for her Award she got from US Embassy in Dar es Salaam as a result of her efforts she has so far made in empowering women and working with communities.

The Chairperson then went through the scheduled programme of the day, indicating agenda items to be presented and discussed.

### **1.2 Presentations from the PF Secretariat and Working Groups**

#### **An Overview of Policy Forum**

Alex Ruchyahinduru presented a paper on who are Policy Forum and a brief history indicating that ad hoc and informal involvement of few civil society organisations (CSOs) in issues of development policy processes (largely PRSP) started way back in 2000. Poor organisation of CSOs and lack of adequate knowledge and capacity to engage in policy processes were among key constraints. Informal activities of Policy Forum as a membership-based organisation started in 2001 with a steering committee providing leadership oversight in policy processes. In 2003 a Secretariat was formally established.

In 2003 to 2006, among other issues, Policy Forum primarily engaged in addressing Poverty Reduction Strategy, in Kiswahili famously known as MKUKUTA; where as in 2008 to 2010 it focused in mainstreaming Social Accountability and Monitoring (SAM) to spearhead governance and accountability activities at local level. In 2011 Policy Forum will continue working on SAM.

The vision of Policy Forum is to have the future where policy processes are participatory and involve the broad-based engagement of all sectors of society, including NGOs and the people they work with, in accountable, empowered, informed and informing manner, at all stages in the policy process and at all levels of society. The mission is to open up and influence policy processes to improve the lives of all people in Tanzania.

The presenter continued to say that the structure of Policy Forum is headed by the General Assembly, followed by Board of Directors, monthly thematic working groups (Local Government Working Group and Budget Working Group) and the Secretariat that runs and implements day-to-day activities.

The key objectives of Policy Forum were said to be:

- Independent and bottom-up analysis for more effective advocacy
- More informed public debates on policy issues
- Enhanced capability of CSOs to constructively influence national and local policy processes
- Strategic and selective policy engagement for greater impact on a social movement for positive change.

Major achievements include analytical support to CSOs, proactive participation in the budget process and more channels of communications. However, the presenter said there are challenges encountered such as:

- Poor participation in working groups
- Some budget documents are not accessible
- Demand for SAM training exceeds the capacity

Solutions have been put in place to address these challenges including increasing the number of staff and capacity building. The presenter reiterated by saying that Policy Forum is a member-led network focused on issues of governance and accountability.

### **Local Governance Working Group**

Hebron Mwakagenda being a co-convener presented activities of one of the Policy Forum working groups – Local Government Working Group (LGWG). He started by saying that, LGWG focuses on local governance, public money and activating citizens' voice. In the past, Local Governance Working Group used to meet on monthly basis, but

now it meets only when issues arise. The presenter continued to say, in 2010 LGWG was mainly involved in the following areas:

- Advocacy against the establishment of the Constituent Development Catalyst Fund (CDCF) and litigation process after the bill was endorsed by the parliament.
- Election related activities such as publications and monitoring
- Engagement in MKUKUTA (cluster III)
- Monitoring Local Government Reform Programme (LGRP II)
- Implementing and monitoring SAM activities

Hebron Mwakagenda concluded by highlighting activities for 2011 as follows:

- LGWG will continue to fully participate in the CDCF case which is ongoing and monitor the implementation processes of CDCF Act.
- Popularise Mining Act of 2010
- Conduct constitutional literacy and awareness creation
- Monitoring LGRP II and MKUKUTA (cluster III) working group meetings
- Implementing and Monitoring of SAM activities
- Conduct a governance survey and build the capacity of LGWG members on how to engage the government

### **Budget Working Group**

Christina Genda introduced and presented the scope of activities of the Budget Working Group (BWG) which has the overall objective of analysing and advocating for equitable, effective and accountable use and acquisition of public money at national and sub-national levels.

The activities of BWG were mentioned as:

- Conducting and sharing information on analysis of public budgets and the budget process from a civil society perspective.
- Producing analytical briefs from time to time for public dissemination.
- Conducting various advocacy activities to influence policy making and implementation.
- Providing a forum for shared learning and capacity enhancement in budget analysis and advocacy.

Noticeable achievements include publications of citizens' budget, training (on extractive industries which triggered changes in the new Mining Act, 2010) and also collaborating with international partners

like Revenue Watch, International Budget Partnership, Tax Justice Network and Center for Social Accountability. The presenter said that poor attendance of group members is a major challenge, which hinders the implementation of activities planned by the group.

The presenter concluded by pointing out future plans of BWG that include producing publications, orientation training on SAM, collaborating with the government in preparing citizens' budget for 2011/12, participating in Public Expenditure Review and General Budget Support meetings, orientation for localisation of Open Budget Index (OBI) and advocating for the establishment of the parliamentary budget office.

### **Comments and Suggestions**

- There is a need for more involvement of grass root actors.
- The issue of CDCF should show clear achievements.
- Councillors do not fully engage in analysing reports of Local Government Authorities (LGAs). Since PF is working at the grassroots level it needs then to advocate the involvement of councillors.

### **Responses**

- Members were reminded that Policy Forum is grant making organization, therefore applying for membership should not be meant it will be getting grants but it will be working for the network.
- It was reported that CDCF case is going in the right track. It was noted that there are criterias for CDCF disbursements as some constituencies get more funds than others for instance Kongwa, Bukombe, Kinondoni, North Kigoma and Morogoro Urban get the largest share.
- The Chairperson said that the budget should be looked at broader context rather than having one issue of PBO.
- One member suggested that presentations should be made in Kiswahili.
- Lastly, it was noted that Policy Forum is relating well with the National Assembly and therefore it should not nullify the presence and the role of civil society organisations.

### **1.3 Presentations from Member Organisations**

#### **MIICO's Social Accountability Monitoring Report**

Adam Siwingwa presented the report of Social Accountability Monitoring project which was implemented by Mbozi, Ileje and Isangati Consortium (MIICO). The report highlights the process and challenges met together with the findings and the way forward for Ileje district. It began in May 2010 by MIICO staff attending orientation training organised by Policy Forum Secretariat.

A team was formed to collect general information related to planning and expenditure of Ileje council. The data collected covered the sectors of health, agriculture and natural resources. The findings revealed the following weaknesses:

- District lacks criteria for making priorities when it comes to allocating financial resources.
- There are cases of implementing activities which were not planned and hence not budgeted for.
- Overspending contrary to the budget allocated with no explanations.
- There is a huge shortage of staff especially in the health sector.

It was reported however, that there are basically a number of planned activities that the district council has managed to implement successfully.

The major challenge that MIICO encounters in implementing SAM is lack of financial resources. For instance, it initially expected to get funds from development partners to no avail.

The presenter ended by saying that after undertaking the first three SAM processes, MIICO is planning to complete the remaining two processes: *integrity* and *oversight management*. The findings will be presented to the district council for further actions. MIICO will then develop a proposal for advocacy on some of the emerging issues especially in health sector.

#### **UNGO's Experience in Social Accountability Monitoring**

The Union for Non Governmental Organisations (UNGO) is an umbrella organisation based in Morogoro with a total of 200 NGOs and 6 networks in Morogoro region. It was established in 1998 and

registered in 2000. Idd Mdanku presented the experience of UNGO in implementing SAM activities since 2008.

UNGO has trained 20 staff who collected in the sectors of water and education in Morogoro and Mvomero district councils. Under the support of Foundation for Civil Society, it is also implementing a 6 month project in the health sector.

The presenter said, after conducting SAM, the district councils are now more responsive and accountable on delivering better services. However there are challenges that include poor planning, poor record keeping and lack of awareness to the community on SAM concept.

### **Comments and Suggestions**

- SAM concentrates more on Local Government Authorities (LGAs) than the people who are the target actors.
- There is no clear way on how to address the shortage of staff in different remote areas and how SAM went down to the people.
- It seems people are not fully participating in SAM, therefore we should begin with the people who have little knowledge.
- It is not clear how sectors were analysed, how conflicting priorities were harmonized and how the representatives of various sectors were selected.
- There is a problem with regards to report writing and there is a need to reject poorly written SAM reports.

### **Responses**

- Stakeholders from various sectors are involved but there is a shortage of staff.
- A warning was given that it is not right for SAM report to be presented by the government representative on behalf of the implementing NGO.
- Policy Forum is still making follow-ups to strengthen SAM to all member organisations.

## **1.4 Selecting Two Partner Organisations or Networks for SAM**

The Chairperson, Moses Kulaba, appointed Richard Angelo to guide representatives of member organisations on the criteria set for

qualified candidate organizations and/or networks vying for the partnership in conducting SAM. The criteria set forth are follows:

- Must be a registered, not for profit, Non Governmental/Civil Society or network;
- A non Dar es Salaam based organisation or a Dar es Salaam based organisation implementing SAM programme outside Dar es Salaam;
- Must demonstrate how Social Accountability Monitoring is compatible with the organisation's long term strategic plan;
- Must allocate funds for implementation of SAM as part of the cost sharing with Policy Forum as per MoU;
- Must demonstrate potential advocacy skills in improving SAM within their designated region or district either by introducing or re-enforcing principles of SAM towards the public and/or government;
- Demonstrated adherence to sound financial management, including externally audited accounts;
- Must be willing and able to apply a set of social accountability and monitoring tools to their current work practices organisation-specific strategy;
- A demonstrated experience/ knowledge with Social Accountability Monitoring, Public Expenditure Tracking System/ Strategies, Participatory Performance Monitoring, Participatory Rapid Appraisal, Public Expenditure Reviews, Citizen's Juries, or Independent Budget Analysis at either regional or local level (Regional Secretariat Budget or Local Government Authorities Budget);
- A demonstrated commitment to, and compliance with, NGO Code of Ethics and the needs of PF NGOs Code of Ethics;
- A demonstrated willingness to commit one member of her staff of a sufficiently qualified level for at least 2 years to coordinate SAM activities at local level (provide CV);
- Being a registered member of Policy Forum or partner and possessing a functional M&E unit manned with adequate professional staff, as well as having strategic plans that illustrate clear vision and commitment to SAM will be an added advantage.

**Note:** identified partner will be trained and assisted to include this work in their future Strategic Planning and in the identification of funding partners. A limited technical support will continue beyond the life of the agreement (two years) provided that this is utilised to enhance social accountability for poverty reduction, equity and democratisation in Tanzania.

The candidate NGOs were ANSAF represented by Audax Rukonge, TAF represented by Heri Uisso, Forum Syd represented by Florence Rugemalira Rweyemamu, and TACOSODE represented by Koga Mihama. Each representative was given a chance to give a brief account of his/her organisation and seek votes from voting members.

It was agreed that only one vote per organisation will be cast and one member voting only twice for two different candidate organisations. The results of the votes were as tabulated below:

TACOSODE with 32 votes and ANSAF with 29 votes were declared the winning two partner organisations in implementing SAM.

## 1.5 Resolutions

- How to write a report should be one of SAM topics towards empowering civil society organisations.
- SAM reports should be printed for members to get copies.
- SAM reports should be presented by the implementing NGOs and not by the local government under scrutiny.
- Ability to analyse data for SAM projects needs skills.
- Capacity building should be more geared to upcountry member organisations.
- The need to establish a Parliamentary Budget Office (PBO) by passing the Budget Act should be given an emphasis so as to help the making of budget processes, especially pro poor budgeting and household budgeting.
- General Budget Support and Public Expenditure Review should be done after making consultations with the government and assessing issues that have been accepted by the government.
- Amani Ndoiyella was recognized with cheering applause as the longest serving member of Policy Forum Secretariat and was awarded a Certificate.
- Tanzania Council for Social Development (TACOSODE) and Agricultural Non State Actors Forum (ANSAF) were selected as partner organisations in implementing SAM.

The Chairperson thanked all participants and wished them well for next day's activities.




a) How was the AGM generally?




c) What particular Pre-AGM component were you interested in?


d) How would you rate AGM proceedings on overall?


e) How did you find the resource materials?

f) Do you think the current AGM is sufficient?




a) How did you get information about the AGM?


b) How did you find the process of refunding?
